Once again, we have spent considerable time in opposition to the new M4 proposals, including the making of a successful and most beautiful video, which showed clearly just how unique is the wetland ecosystem of the Gwent Levels. We are delighted that the Welsh Government has been so impressed by our campaigning, which was supported by so many of you, that the scheme has now been permanently cancelled, with environmental concerns being cited as the principal reason.

Education is a vital part of our work, and the numbers of children and young people that we reach continues to grow every year. It is our children's future that is threatened by climate change, and it has been most moving this spring to see children themselves, all across the world, making their voices heard in demanding action to mitigate climate change. Here in GWT we are working with them.

If it wasn't for you, we would not be able to achieve all that we do. Mv Wild Newport

In July 2018, we launched a new project, funded by NRW and working with Newport City Council to promote wellbeing through enjoyment of the city's many green spaces. Since then..

We've established a new monthly volunteering group, with 15 new volunteers!

> We've delivered 5 litter picking days, 2 footpath maintenance tasks, 5 school engagement activities, 2 guided walks and 6 x invasive species removal tasks on Newport's green spaces.

> 20 businesses have got engaged in wildlife conservation volunteering.


