# TRUSTEES REPORT (INCLUDING DIRECTORS' REPORT AND STRATEGIC REPORT) FOR THE YEAR ENDED 31 MARCH 2020

The Trustees present their report and financial statements for the year ended 31 March 2020.

The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the Trust's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016).

#### Objectives and activities

The Gwent Wildlife Trust (GWT) Public Benefit Statement (as required by the Charity Commission) is enshrined in paragraph 3 of our Memorandum of Association.

- 1. For the benefit of the public, to advance, promote and further the conservation maintenance and protection of:
- (i) terrestrial and marine habitats and their wildlife;
- (ii) places of natural beauty;
- (iii) places of zoological, botanical, geographical, archaeological or scientific interest;

GWT's policy is to consult and discuss with employees, through unions, staff councils and at meetings, matters likely to affect employee's interests.

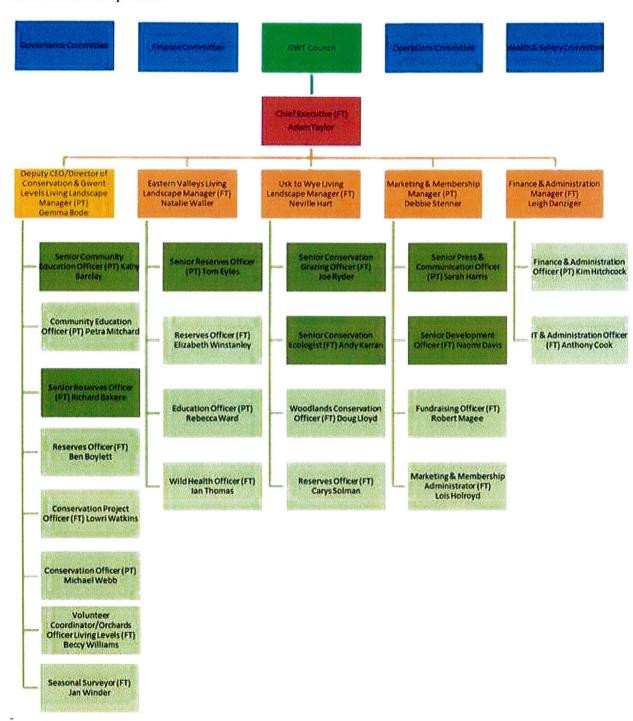

#### Achievements and performance

#### Investment performance achieved against investment objectives set

In the financial review section of this report there is a description of the investment policies and objectives established by the trustees and the extent to which social, environmental or ethical considerations are taken into account.

The Trust's funds are held in two bank current accounts and four savings accounts (COIF higher-rate charity bank account, CAF/Shawbrook, Lloyds x2). Interest was received as expected from these sources.

#### Factors relevant to the achievement of the charity's objectives

During March 2020 Covid-19 became more prevalent, leading the government to implement movement restrictions from the 23rd of March. This had a minor impact on delivery of some works. However it did not result in any of our charitable objectives becoming unachievable.

#### Summary of the main achievements of the charity during the year

All areas of the Trust's work achieved satisfactory or good results during the year.

Gwent Wildlife Trust ran its fourth full year of activities through its Living Landscapes structure between April 2019 and March 2020. The year was, again, one of high energy and notable success. These are some of the highlights for this year:

#### **Gwent Levels Living Landscape Area:**

The last year's activity across the Gwent Levels has once again continued at pace. One of the highlights was our acquisition of Bridewell Common, 80 acres of land lying to the east of Magor Marsh. A real GWT team effort we fundraised a considerable amount of the purchase price through our very generous membership appeal, a contribution from the Pat Gorvin legacy and a variety of external grant sources. Bridewell has huge potential in enhancing the SSSI wildlife features found on the Gwent Levels but also to alleviate the visitor pressure at Magor Marsh for those wanting a quieter wildlife watching experience, However, there is much to do on site before it can be opened to the public.

The Projects that we lead as part of the Heritage Lottery funded Living Levels Scheme have been progressing well. The Learning Project has produced an outstanding Learning Resource for Teachers based around the history and wildlife of the Gwent Levels. This supports curriculum linked local learning with our INSET courses for Teachers with this resource receiving some great feedback. Our Natural Heritage Project restoring field ditches across the Levels experienced delays due to one of the wettest winters on record, However, these are now planned in for the coming winter and achievable within these extended timescales. The recruitment of a Volunteering Officer to the Scheme has led to a large rise in volunteers becoming involved with the multiple projects of the scheme and taking advantage of the opportunities to learn more about this amazing landscape.

Many of the Volunteers becoming involved with the Living Levels are also part of the Levellers volunteer group who continue to commit a huge number of hours toward management of nature reserves on the Levels from litter picking the Peterstone foreshore to repairing the boardwalk at Magor Marsh and clearing scrub at Great Traston Meadows. Their yearly commitment of 1000's of days towards our work is always humbling.

Our Education Centre at Magor Marsh continues to be the main Education hub for the Trust with hundreds of school children learning about the wonderful wildlife that can be found there. As school budgets shrink however we are experiencing a decline in schools getting in touch for visits and this is a cause of concern for the future. Our Wildlife Wizards quiz supported by Eastman saw a record number of schools participating in 2019 with over 25 from all over Gwent from both state and private schools; Shirenewton Primary were the worthy winners this year.

We continue to stand up for wildlife with our input into planning casework that affects wildlife. On the Levels that involves inputting into solar farm and wind turbine applications affecting ground nesting birds and the SSSI features. Llandegfedd Reservoir SSSI has also required an objection due to their Centre change of use application affecting bird populations. We are hopeful to build on our M4 Campaigning work to begin direct discussions with the Welsh Government to permanently stop further developments effecting the Gwent Levels.

Our My Wild Newport Project has been very successful in partnership with Newport City Council. It has been encouraging people to get to know their local greenspaces and volunteer, with hundreds of hours completed managing these oases for people to enjoy and wildlife to thrive in.

#### Usk to Wye Living Landscape area:

The wildlife within our woodlands has benefitted from continued winter work at Croes Robert SSSI, revitalising the rides and the designated, coppice woodland feature, as well as benefitting hazel dormice. Our work has again been facilitated by the involvement of two trainee reserves officers, made possible by funding from Wye Valley AONB, Belvedere Trust and D'Oyly Carte Trust. This relationship with trainees has resulted in 1 trainee gaining employment as an ecological consult, while the other continues to work with GWT into the spring. The first year of managing Piercefield Woods (SSSI/SAC) has been successful with prioritised ash tree felling helping to manage the decline of this ecologically important tree species and minimizing the threat of dying trees to visitors. Further sampling of deadwood invertebrates has shown that this woodland, along with the neighbouring SAC wood is technically the 3rd best site in Wales for deadwood beetles.

This landscape currently supports about 60% of the Trust's land holding, of which approx. 66% are grassland habitats. Management of Glastir contracts has been a key focus to deliver both agreed annual management and capital upgrades. Management of graziers and contractors has provided a range of benefits to the Trust with staff managing the inherent challenges. Across a number of sites, wildlife has benefited from changes to our hay and grazing approaches, scrub management, creation of uncut 'rough margins', grassland restoration, and creation of 'leaky dams'. Two members of the team moved on to new jobs in the autumn, which facilitated change and after a short gap, two new employees have rapidly got to grips with our site management. Extremely skilled and competent volunteers stepped in to ensure the welfare of the Trust's livestock in the interim and despite the change, the Trust's organic 'meat box scheme' has created valuable income.

This years' upsurge in climate awareness and tree planting has generated a developing partnership with Cardiff University via their Phoenix Project. Their funding and involvement helped create a number of tree planting plots, designed to provide more in-field trees and the potential veteran trees of the future at Wyeswood Common.

Ecological and technical support for individuals and organisations has increased this year through the Trust's Senior Ecologist with ongoing surveys of potential local wildlife sites, LWS panel meetings and newsletters, input into other Trust projects, articles and delivery of many summer walks and talks. The Kew Tree Seeds Project concluded with the last collections of willow species and shrub species seeds across Gwent and its surrounds.

The Wild Health Project has continued apace with the project surpassing expected outputs and outcomes and gained additional funding allowing reserve staff and education officers to become more involved in helping to deliver additional sessions and outputs. The Trust began its involvement in a local project designed to improve the mental health of PTSD sufferers who were formerly employed with the emergency services or armed forces. Trust staff act as trainers for participants, utilizing staff skills and experience, extending our influence and developing further links and partnerships.

At a landscape and county level, ongoing involvement in partnership projects and funding steering panels, input into NRW's development of Area Statements, support for community involvement in Monmouth, funding applications for replacement machinery and development of landscape scale projects and partnerships has complemented and supported the team's successes.

#### Eastern Valleys Living Landscape area:

The 2019-20 financial year has been a busy one for the Eastern Valleys Living Landscape Team, consisting of reserve work, events, engagement and training. Most notable was the culmination of the Heritage Lottery Funded project, Where's Your Wildlife, at the end of October. This two-year project engaged local communities in discovering, exploring and caring for wildlife on three post-industrial sites in Blaenau Gwent and Torfaen – Silent Valley, Central Valley and The British. Through this project, 17 'Discovery Days' were delivered, on a range of species or habitat specialisms, attended by nearly 200 people. An additional 140 people took part in practical habitat management of the three sites, and our Education Officer, worked with 180 young people.

During the summer of 2019, two students from a French University joined us for a three-month placement. They carried out adder surveys of Silent Valley (none recorded, unfortunately!) and completed a baseline survey of the fields at the top of the reserve which are now fenced off from wandering sheep. We are hopeful that the over grazing the fields experienced will be reduced, and therefore the acid grassland will regenerate. The baseline survey will be a good starting point for future years and enable us to the monitor the changes.

#### Eastern Valleys Living Landscape area: (continued):

Our reserve officers continue to manage the reserves in this area, with the help of 1500 hours of volunteer time. Work has included gate installations, hedge laying, meadow management and pond clearance. This year saw a lot of development focused on one our more urban nature reserves, Central Valley. Blaenau Gwent's Public Service Board led a project – Blaenau Gwent on the Move – to develop and improve a new 6 mile walking trail named the Ebbw Fawr trail. It passed through Central Valley Reserve, with the project encouraging more people to get outdoors to keep fit, healthy, and appreciating their local area. As part of the project, Central Valley has had two chainsaw sculptures installed, along with a series of interpretation boards and repairs to drystone walls on the site.

Our Education work has seen a similar decline as at Magor, and the Eastern Valleys Education Officer has been spending time working alongside the Wild Health Officer, running some activity sessions for young people and adults with learning deficits and mental health issues. She continues to work on a weekly basis with the 16+ group from Pen y Cwm school, the special needs school next door to the ERC. The students have been working towards their John Muir award at Silent Valley.

Training has also featured for the team this year, with our Reserve Officer gaining her Vet Meds certificate, meaning that she is able to administer medication to our flock of sheep if required, and our Education Officer has undergone training in Hill and Moorland Leader and Outdoor Learning. The Senior Reserve Officer is now able to deliver training on ATVs (all-terrain vehicles, or quadbikes), adding to the brushcutter qualification that he can already deliver. As such, he has delivered a number of NPTC certified training courses for our staff, volunteers and external organisations, not only saving GWT money but earning income also. There has also been training delivered (by the EV Manager and Magor Marsh's Senior Education Officer) in both Outdoor Learning and Forest School Leader (Agored Cymru accredited qualifications).

#### Support Team/Fundraising and Membership

2019/20 was a very successful year in terms of our fundraising and membership.

Two new staff joined our team (Naomi Davis as Senior Project Development Officer, a little earlier in November 2018 and Lois Holroyd as Marketing and Membership Administrator in April 2019), replacing colleagues who had moved on. Several volunteers also joined the team and have made tremendous contributions in the areas of reporting and analysis, (Rebecca), events promotion (Sue), digital campaigns (Nanette) and website development, (Katy.) We launched our 5-year Funding Strategy, making substantial headway against all objectives.

One of these objectives is to **build our profile and reputation across Gwent**. This was undoubtedly bolstered by our successful campaign against the M4 which came to such a positive conclusion in the first quarter of 2019/20 when the First Minister, Mark Drakeford, shelved plans. Our national campaign engaged over 7,000 people in emailing objections to the First Minister and 21,000+ people also signed the # NoNewM4 petition.

Alongside this, we report overall growth in followers and 'likes' across all our social media channels (Twitter, Facebook and Instagram), with 1,008 new followers over the year. The biggest growth has been on Instagram, with 426 new followers in the year. We had stronger engagement and uplift during our appeal to purchase Bridewell Common but it was not only the big campaigns that drew a crowd. In Spring 2019, the amazing video footage of a Dark Edged Bee-fly as it was getting ready to fly, captured and shared by our Senior Comms Officer was seen 65,598 times and generated a whopping 1,960 engagements (likes, shares and comments.)

We also made headway in our objective to make it easier for people who care about wildlife to support us. We launched our new website in January 2020 with a clear focus on engaging supporters, including members, donors and volunteers.

We are increasingly building support by sharing emotive photography and film and were delighted to win the video category of The Wildlife Trust's national storytelling competition with our Save the Gwent Levels film "Leisure", narrated by actor Aimee Ffion Edwards.

#### Support Team/Fundraising and Membership: (continued):

In terms of scaling up fundraising activities, we held a successful 7th Race for Wildlife event, increasing accessibility to a wider audience with shorter family races alongside the 10k and with more people raising funds through sponsorship for their running challenge.

We were overwhelmed with the support of our members for our Bridewell Appeal, which, alongside the generous legacy left by Pat Gorvin and highly significant grants particularly from The Banister Trust, NRW and HLF, enabled us to meet our target and buy the new Nature Reserve. We raised £168,000 from Charitable Trusts and Foundations with another £16,400 towards future management works. Our members responded generously to our appeal letter and articles in our membership magazine, contributing over £80,000 (including gift aid.) Our community fundraising which included sponsored challenges by GWT staff (most notably Senior Reserves Officer Richard Bakere's coracle down the Wye challenge!) raised over £6,000. Overall our Bridewell Appeal raised a total of £255,302 in just five months.

Retaining and growing membership remains pivotal to our vision and mission, collectively making by far the greatest contribution to our voluntary income whilst supporting our work widely across all our conservation aims and objectives. After allowing for membership cancellations, we grew our membership by 62 memberships in the year against a challenging operational backdrop, and had 3,499 members at end of March 2020. We recruited 377 new members in the year, which was 152 more than the average of the previous 3 years. This growth in membership recruitment mainly came via our website, as a result of our digital and social media marketing. For example our Christmas membership video-ad, created by volunteer Nanette Hepburn and featuring our Conservation Director, Gemma and her family performed well on social media and contributed to strong uplift in December gift membership.

We carried out a survey of our membership and 93% of responding members said they were proud to be a member of Gwent Wildlife Trust, and 92% rated our membership magazine as 'good' or 'excellent'. The feedback from our members is helping inform our strategy and marketing and communications.

#### **Pat Gorvin Legacy**

In 2017/18 GWT received a significant proportion of the Pat Gorvin Legacy (£2,654,000). Mrs Pat Gorvin was a member of Gwent Wildlife Trust from the mid-1960s. Pat and her husband supported GWT through thick and thin until their old age. Pat survived her husband and continued to help us – donating £50k in the year of GWT's 50th Anniversary. Sadly, Pat passed away in 2016 but she left 60% of her estate to GWT in her will. That generous action has bolstered our work through an injection of over £2 million. Such substantial gifts are uncommon and will help us deliver better outcomes for wildlife and people's enjoyment of biodiversity in Gwent. Funds have been designated to bolster conservation efforts, and to invest in the long-term sustainability of GWT. The designations, estimated to last 5 years from receipt of Legacy Funds, are as follows:

A steering group, comprised of Trustees and Senior Staff, ensures that funds are applied in ways consistent with GWT's Charitable Objectives and its Strategic Plan. The Income Generation Designation is particularly significant since this is where GWT's Legacy funds are applied to enable continued charitable function after the five years duration of the Gorvin Legacy fund. The Revenue Protection Designation ensures that GWT retains its effectiveness and capacity during the period of the Gorvin Legacy Fund.

#### **Gwent Ecology Limited**

Gwent Ecology exists to fulfil a number of purposes. Principally, it generates unrestricted funding for GWT through consultancy work from bat surveys to large-scale landscape design, via a mixture of GWT staff and external subcontractors. In addition to generating profit, Gwent Ecology makes a direct contribution to cover staff-time, training and other GWT staff overheads. It also provides a vehicle to enable staff to grow their own professional skills and abilities in a commercial setting and, potentially a future career opportunity for staff as the business develops. Importantly Gwent Ecology also enables GWT to influence developers, individuals and businesses to ensure that projects are delivered with biodiversity in mind.

Gwent Ecology delivery: Surveys of breeding birds, veteran trees and grasslands took place at the National Trust's Clytha Estate; surveys were completed for The Woodland Trust's 'Plantations on Ancient Woodland Sites' (PAWS) project; co-development of a revised management plan for the Blorenge SSSI; and surveys of Llanhilleth Common.

#### Financial review

The Statement of Financial Activities show incoming resources for the year of a revenue nature of £984,264 (2019: £763,729).

The total reserves at the year-end stand at £3,360,166 (2019: £3,543,337).

#### Reserves policy

The Trust aims to hold an unrestricted financial reserve equal to a minimum of 3 months operating costs at £281,000. The year closed with an unrestricted reserve of £1,823,660 of which £1,702,493 is designated. Many of the operating costs included within the 3 months cost calculation are costs which are covered as part of the designated funds therefore the reserves policy was achieved.

#### Funds in deficit

At the year-end, there was a deficit in, Glastir Advance of £5,542 to be repaid by December 2020, in ENRaW of £30,248 to be repaid by July 2022, in Living Levels Natural Heritage Restoration & Volunteer Co-ordinator of £7,442 to be repaid by July 2021, in Living Levels Education & Local Wildlife Sites of £4,913 to be repaid by July 2021. There was also a deficit in ABP Gwent Levels of £1, in Wildlife Wizards of £1,387, in the Magor Marsh Education of £1,435 and in Pentwyn Farm Meadows of £876; all to be repaid during 2020/21.

#### Financial performance of the charities subsidiary undertakings

During the year, Gwent Ecology Limited elected to gift £17,198 (2019: £11,603), being its profits for the year ended 31 March 2020, to Gwent Wildlife Trust Limited.

#### **Share Capital**

The company is limited by guarantee and therefore has no share capital.

#### **Plans for Future Periods**

During 2020/21 GWT is undergoing four Operational Reviews, covering all significant areas of our work, to ascertain which of these areas will expand, which will continue at their current level and which will cease. These reviews will be completed by October 2020 from which time, until March 2021, GWT's Strategy, Structure, Business Plan and Budgets will be amended in readiness for the next five financial years; 2021/22 - 2025/26.

In the year ahead Covid-19 will result in GWT having to adapt its operating model which previously involved large audiences, as this will not be possible for the foreseeable future, and we envisage a small decline in donation and membership income, however, due to GWT's innovative staff and strong cash reserves we are well placed to address these issues.

Ash Dieback is a developing issue for landowners with the financial and health and safety implications predicted to be significant. Work has begun to equip and train staff to deal with this threat, with surveys of the entire GWT estate due to be completed by the end of July 2020 and works to address the identified issues scheduled to take place (government permissions permitting) between September 2020 and April 2021.

#### Structure, governance and management

The Trust is governed by its Memorandum and Articles of Association, which were revised at the Trust's 2005 AGM. They were further amended at the 2010 AGM to give the trustees discretion to appoint a patron of the charity. At the 2012 AGM, a resolution was agreed to increase the maximum number of trustees from 12 to 15 and to allow trustees to serve for two consecutive terms of five years. Co-opted Trustees are put forward for election at the AGM. If elected they become Appointed Trustees of Gwent Wildlife Trust.

Trustees are elected by the membership at the Annual General Meeting. All prospective trustees complete application forms; suitable candidates are then shortlisted for interview by a panel of trustees and a staff member; and recommendations for co-option are made at the following meeting of Council. Co-opted trustees will then be recommended to the membership for election at the following AGM. Potential trustees can contact the Trust direct for a form; but in order to increase the trustee diversity, advertisements are now being placed when there are vacancies on Council and this has resulted in an increase in younger trustees and in a greater percentage of female members.

None of the Trustees has any beneficial interest in the company. All of the Trustees are members of the company and guarantee to contribute £1 in the event of a winding up.

GWT's Council meets six times a year to make decisions on policy and strategy. A work plan and budget for the year is set at the March Council meeting. An Annual Report and Accounts is presented to the May meeting of Council and thereafter to the Annual General Meeting in September. Staff, trustees and other appropriate individuals meet regularly in advisory working groups.

Day to day management of the charity is delegated by the charity trustees to the Chief Executive. Members of staff undertake work in line with the organisation's strategy, policies, work plan and budget. Staff, trustees and other appropriate individuals meet regularly in advisory working groups.

#### Membership of a wider network

GWT is part of the Wildlife Trusts partnership, which encompasses 46 Wildlife Trusts covering all of the UK, plus the Isle of Man and Alderney. Within this wider network, GWT works particularly closely with the other four Welsh Wildlife Trusts.

#### Relationships between the charity and related parties, including subsidiaries

Gwent Wildlife Trust is a corporate member of, and pays contributions to, the Royal Society of Wildlife Trusts (RSWT) and Wildlife Trusts Wales (WTW), both of which are registered charities. GWT provides a trustee to WTW, and WTW provides a trustee to RSWT.

Gwent Wildlife Trust is divided into the following departments: Finance & Administration, Marketing & Membership, Eastern Valleys Living Landscape Area, Gwent Levels Living Landscape Area, and Usk to Wye Living Landscape Area. During the financial year being reported upon, Gwent Ecology Limited provided a range of ecological services to local organisations.

# NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2020

#### 1 Accounting policies

#### **Charity information**

Gwent Wildlife Trust Ltd is a private company limited by guarantee incorporated in England and Wales. The registered office is Seddon House, Dingestow, Monmouth, Monmouth, NP25 4DY, United Kingdom.

#### 1.1 Accounting convention

The accounts have been prepared in accordance with the Trust's governing document, the Companies Act 2006 and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102)" (as amended for accounting periods commencing from 1 January 2016). The Trust is a Public Benefit Entity as defined by FRS 102.

The financial statements are prepared in sterling, which is the functional currency of the Trust. Monetary amounts in these financial statements are rounded to the nearest £.

The financial statements have been prepared under the historical cost convention. The principal accounting policies adopted are set out below.

#### 1.2 Going concern

At the time of approving the financial statements, the Trustees have a reasonable expectation that the Trust has adequate resources to continue in operational existence for the foreseeable future. Thus the Trustees continue to adopt the going concern basis of accounting in preparing the financial statements.

#### 1.3 Charitable funds

Unrestricted funds are available for use at the discretion of the Trustees in furtherance of their charitable objectives.

Designated funds comprise funds which have been set aside at the discretion of the Trustees for specific purposes. The purposes and uses of the designated funds are set out in the notes to the financial statements.

Restricted funds are subject to specific conditions by donors as to how they may be used. The purposes and uses of the restricted funds are set out in the notes to the financial statements.

#### 1.4 Income

Income is recognised when the Trust is legally entitled to it after any performance conditions have been met, the amounts can be measured reliably, and it is probable that income will be received.

Cash donations are recognised on receipt. Other donations are recognised once the Trust has been notified of the donation, unless performance conditions require deferral of the amount. Income tax recoverable in relation to donations received under Gift Aid or deeds of covenant is recognised at the time of the donation.

Legacies are recognised on receipt or otherwise if the Trust has been notified of an impending distribution, the amount is known, and receipt is expected. If the amount is not known, the legacy is treated as a contingent asset.

#### 1.5 Expenditure

Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

# NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) FOR THE YEAR ENDED 31 MARCH 2020

#### 1 Accounting policies

(Continued)

#### 1.6 Tangible fixed assets

Tangible fixed assets are initially measured at cost and subsequently measured at cost or valuation, net of depreciation and any impairment losses.

Depreciation is recognised so as to write off the cost or valuation of assets less their residual values over their useful lives on the following bases:

Plant and equipment

25% on cost

The gain or loss arising on the disposal of an asset is determined as the difference between the sale proceeds and the carrying value of the asset, and is recognised in net income/(expenditure) for the year.

#### 1.7 Heritage assets

Heritage assets relate to the charity's nature reserves which are recorded at cost.

The heritage assets have been reviewed at the reporting date with no impairment noted.

#### 1.8 Financial instruments

The Trust has elected to apply the provisions of Section 11 'Basic Financial Instruments' to all of its financial instruments.

Financial instruments are recognised in the Trust's balance sheet when the Trust becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

#### Basic financial assets

Basic financial assets, which include debtors and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the transaction is measured at the present value of the future receipts discounted at a market rate of interest. Financial assets classified as receivable within one year are not amortised.

#### **Basic financial liabilities**

Basic financial liabilities, including creditors and bank loans are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest. Financial liabilities classified as payable within one year are not amortised.

Debt instruments are subsequently carried at amortised cost, using the effective interest rate method.

Trade creditors are obligations to pay for goods or services that have been acquired in the ordinary course of operations from suppliers. Amounts payable are classified as current liabilities if payment is due within one year or less. If not, they are presented as non-current liabilities. Trade creditors are recognised initially at transaction price and subsequently measured at amortised cost using the effective interest method.

#### **Derecognition of financial liabilities**

Financial liabilities are derecognised when the Trust's contractual obligations expire or are discharged or cancelled.

#### 1.9 Employee benefits

The cost of any unused holiday entitlement is recognised in the period in which the employee's services are received.

Termination benefits are recognised immediately as an expense when the Trust is demonstrably committed to terminate the employment of an employee or to provide termination benefits.

#### 2 Critical accounting estimates and judgements

In the application of the Trust's accounting policies, the Trustees are required to make judgements, estimates and assumptions about the carrying amount of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised where the revision affects only that period, or in the period of the revision and future periods where the revision affects both current and future periods.

#### 21 Contingent liabilities

Ash Dieback is a developing issue for landowners with the financial and health and safety implications predicted to be significant. Work has begun to equip and train staff to deal with this threat, with surveys of the entire GWT estate due to be completed by the end of July 2020 and works to address the identified issues scheduled to take place (government permissions permitting) between September 2020 and April 2021. The financial implications are difficult to predict ahead of the completion of these surveys, however GWT have allocated a nominal figure of £165,000 (£5,000 per nature reserve) to address this issue, with more funding forthcoming should it be required. In addition GWT will be redeploying its nature reserve staff from all non-essential (legally or contractually obliged works) to address this challenge this winter within the existing salary cost envelope. As such this £165,000 allocation will primarily be consumed in the appointment of specialist contractors to deal with the most technically challenging issues.

#### 22 Operating lease commitments
